## **TOWN OF TUSAYAN**

## PROPOSITION 400

Referendum ordered by petition of the people relating to amending the Town of Tusayan Zoning Ordinance.

The Town proposes to amend its Zoning Ordinance to increase the building height limit to 65 feet in certain zoning districts, allowing the Town to grant exceptions, provided all Federal Aviation Administration requirements are satisfied.

A "yes" vote shall have the effect of amending the Town's Zoning Ordinance.

A "no" vote shall have the effect of allowing the existing Zoning Ordinance to continue unchanged.

## ARGUMENTS FOR AMENDING THE TOWN'S ZONING ORDINANCE

As a member of the Tusayan Planning and Zoning Commission, I voted in favor of the proposed 65- foot building height limit in Tusayan. I've lived in Tusayan for 17 years and plan to continue living here for many more. With the limited housing options and town services, it will be necessary to move to another location as all previous residents have been forced to do when time to retire. Not much has changed here in the last few decades, and several efforts in recent years to add new amenities have been challenged or stalled, mostly by outside opponents. That's why Tusayan incorporated- so we can make our own decisions on what's best for our town. Setting the building height limit at 65 feet- just a few feet higher than the IMAX where I work — would allow for new housing and services that both residents and visitors can enjoy. More services and housing will allow for competition and lower prices for residents in Tusayan. I urge residents to vote for more opportunities by voting YES on Proposition 400.
